A Message from the Foundation President


Dear Friends,

MISSION STATEMENT: Our Goals


We remain dedicated to our slogan, "Investing In Our Future" and have the following goals:

ASSETS

In December, 2019, The Wayne County Community Foundation began working with Cornerstone Advisors Asset Management, LLC to help oversee our investment portfolios. Our investments are managed by four local institutions, The Dime Bank, Honesdale National Bank, Wayne Bank and Morgan Stanley. Investment results are reviewed on a quarterly basis with our investment committee, treasurer, executive director and Cornerstone along with each of the representatives of these institutions. As of June 30, 2020 our total investments assets were over \$5.4 million dollars.

COVID-19 Response



In response to the COVID-19 pandemic, The Wayne County Community Foundation established the Wayne County Emergency Food Relief Fund in partnership with the Wayne County Commissioners to raise funds to help the local food relief efforts in our community. Over \$230,000 has been raised from generous donations from local individuals, businesses, community groups and foundations. These funds have purchased food to help feed over 11,000 people. Local products like eggs, milk and produce are a priority for this fund, enabling a connection between farmers and community member in need. We also worked with the Area Agency on the Aging to establish a Senior Meals fund in March to assist the county in raising funds from the community to support meals being delivered to senior citizens during the pandemic.



The Wayne County Community Foundation received a grant for \$118,000 from the Department of Environmental Protection in partnership with Wayne County to support Emergency Food Infrastructure cold storage improvements.


YOUTH ADVISORY COMMITTEE

The Youth Advisory Committee (YAC) was created through a generous bequest of Eleanor Ferro and the Foundation in order to familiarize Wayne County High School students with philanthropy and grantmaking. Students in grades 9-12 participate in the committee and accept mini-grant applications and work together to decide how the funds are distributed.

In the past year, the YAC made mini grants totaling \$3,000 to projects at Wallenpaupack Area School District, Wayne Highlands, Western Wayne and Canaan Christian Academy.

AID TO EDUCATION



BUILDING HOME LIBRARIES

For the past 14 years the Foundation and its donors have purchased Scholastic children's dictionaries for 3rd graders at local elementary schools. These dictionaries have been enjoyed by over 5000 students over the years and have been a great start to helping students build their home libraries. 
